I. The Indian Computer Emergency Response Team (CERT-In) released a high-severity alert concerning multiple vulnerabilities found in Apple Vision Pro. Apple Vision Pro operates on the newly developed VisionOS. Reports suggest that it is susceptible to severe security breaches. News comes in that the vulnerabilities found in Apple Vision Pro can allow malicious actors to seize control of your system, access confidential user information and cause significant disruptions.

Experts suggest that the device can allow attackers to execute arbitrary code with kernel-level privileges. This capability would enable attackers the highest level of access to the system. The expected threat can pass in through many built-in security mechanisms, enabling it to install malicious software or alter system settings without detection. The root causes of these vulnerabilities can be various technical issues within the VisionOS components. "These include 'use-after-free' bugs in the kernel, errors in the CoreMedia and libiconv components, out-of-bounds write and access issues, integer overflows, and type confusion errors in the WebKit component. These technical flaws can be exploited by attackers through maliciously crafted web content, leading to memory corruption and system compromise, ,"as reported by CERT-In.It looks like Apple might have released a software update for the Vision Pro. CERT-In seems to have advised all users to promptly download and install this update to protect their devices from potential exploits. In addition to this keeping the software up to date is crucial in 'safeguarding against these vulnerabilities and ensuring the security and integrity of the system,' CERT-In explained.

II. In the emerald countryside of Wales sits a manor named Nantclwyd Hall. Built 400 years ago, the luxurious two-story brick sanctuary is painted peach and capped with a gently sloping slate-gray roof. Surrounding it are acres of neatly geometric gardens, adorned with ornate temples and whimsical structures that stand like stone jewels amid long fields of trimmed grass.

Inspired by a ball game played indoors by aristocrats for centuries, Wingfield's innovation was to move the game outside and replace the leather ball with a bouncing rubber one. The game was a hit. Within months, Wingfield had patented sphairistike. He began a business, published two books to promote the game and sold playing sets. Presented in a handsome, long wooden box, a typical set included written instructions, a long net, court markers, a rubber ball, pegs and tape to mark the court, and four lopsided rackets—to better to hit the low-bouncing ball. In the first year, Wingfield sold a thousand sets that quickly spread across the British Empire and beyond. Just three years later, in 1877, the first tournament of champions for lawn tennis, as the sport became known, was held at Wimbledon.

Although the major's game of tennis is rarely recognized as a product of hominin evolution, the ability to strike a bouncing ball with a racket is evidence of an ancient symbiosis between human and tool. Consider what happens when you pick up a tennis racket the first time. At that moment, the racket is just a thing. An external object in the world. Next, a ball is tossed in your direction to strike. With more



practice, each swing becomes more natural, each ball hit more precisely as your hand feels ever more at home wrapped around the grip. A Philosophy of Sport, one possible origin for the word "racket" is rachette, Middle French for the palm of the hand. This etymology suggests how the racket becomes a part of the hand itself.

More than 100 leaders, including the US vice-president, Kamala Harris, and the presidents or heads of the EU, South American, Middle East and Asian countries, will gather in Switzerland for one of the most ambitious attempts yet to forge a peace plan for Ukraine. The summit comes as G7 leaders gathering in Italy clinch a new deal for a €50bn loan for Ukraine, securitised through use of the windfall profits from the interest on Russian central bank assets frozen by the EU and other western nations after the 2022 invasion of Ukraine.

The two-day peace conference, which will take place at the luxury Bürgenstock resort outside Lucerne, will discuss Kyiv's proposed 10-point plan to end the war along with three other themes: the nuclear threat, food security and humanitarian needs in Ukraine.

It follows the Russian president, Vladimir Putin, demanding that Kyiv cede more land, withdraw troops deeper inside its own country and drop its Nato bid in order for him to end his war in Ukraine – proposals that were rejected by Ukraine, the US and Nato.

A joint communique is expected to centre on the importance of the UN principles on maintaining and respecting "sovereignty and territorial integrity".

While this is not seen as advancing peace in itself, it is designed to "reduce the space for any unhelpful initiatives.

This will be seen as a success for Volodymyr Zelenskiy who is aiming to build international support for his peace plan that includes a full withdrawal of Russian troops from Ukraine and return to its 1991 post-Soviet borders. Organisers of the peace summit played down China's decision not to attend, a move that prompted Zelenskiy to accuse Beijing of helping Moscow undermine the meeting, which China's foreign ministry denied.



Kyiv had been pushing hard for a Chinese delegation to attend the summit to give the conference further legitimacy and drive a wedge between Moscow and Beijing. There were also hopes that Saudi Arabia may attend after what Zelenskiy described as "productive and energetic" talks with the Saudi crown prince Mohammed bin Salman. Moscow has dismissed the meeting as futile.

The volcanoes along Mars' equator are massive, imposing features, with some peaks towering more than twice the height of Mount Everest. Olympus Mons, the tallest, is as wide as France. Now, a new discovery adds to the mountains' intrigue: the presence of early morning frost. According to a study, a winter frost periodically covers extensive patches of Mars' Tharsis region, home to a dozen volcanoes—providing the latest evidence of water on Mars and the first sighting of water at the planet's equator. For a few hours each morning, before sunlight directly strikes the equator, some craters at the volcanoes' summits are coated in a layer of water frost. This icy film is thinner than a human hair, but it covers so much area that the amount of water accumulating daily at the peaks, researchers estimate, could fill 60 Olympic-sized swimming pools. What we're seeing could be a trace of a past Martian climate. It could be related to atmospheric climate processes that were operating earlier in Martian history, maybe millions of years ago.

Astronomers spotted the frost when analysing roughly 30,000 high-resolution colour images of Mars captured by the European Space Agency's (ESA) Trace Gas Orbiter. The international team confirmed the pictures were indeed of frozen water—not of carbon dioxide, which can appear similar—by calculating that the volcanoes' temperature was too hot for carbon dioxide to freeze. Researchers already knew the planet's northern and southern polar ice caps hosted water ice, and the new finding adds another site to the map of Mars' water. This is quite exciting, because it tells you how dynamic Mars' water system is, but also how water can be found in different amounts basically everywhere on Mars. Scientists previously thought Mars' equator was too hot—and its atmosphere there too thin—to support frozen ice. But the finding of frost is evidence of a more nuanced water cycle, one made possible by a microclimate atop volcanoes. There, mountain winds carry moist air into craters called calderas that are, during certain seasons, cool enough for condensation to occur. This process is "decidedly Earth-like".

The discovery was made with a combination of intention and luck. Most other Mars orbiters are synchronised with the sun, which means they don't observe the planet's equator until the afternoon, when the frost has already melted away. Mars also has only a narrow, seasonal window when frost can form. The researchers were looking for frost in other equatorial regions for a different project and were surprised when they found it on volcanoes' peaks. As space agencies look toward sending humans to Mars, discoveries of water are crucial, experts say.

The Illuminati and other secret societies inspire our imaginations, both for better and for worse. There's something about them that's irresistibly intriguing. But why? In the simplest sense of the term, a secret society is any organization that maintains a measure of secrecy, whether it conceals its aims, its activities, its membership, or any other aspect of its operations. In fact, though the specific definition of the term is still disputed, descriptions of secret societies tend to stress the sharing of secret knowledge and the administration of secret rites, rituals, and initiations, meant to set members and non-members apart. Those who know the secret are the insiders, 'us.' Those who do not know the secret are the outsiders, 'them'.

Though the majority of modern secret societies fulfill a social function — fostering friendships, creating communities, circulating ideas, and carrying out charitable services — there are many other types of secret societies, too. Some secret societies safeguard religious secrets and trade skills. Others promote particular political aims, reactionary as well as revolutionary. Others still fulfill several simultaneous



functions, all at once, and all from the shadows. The driving forces of secret societies are so diverse that some scholars include the Mafia among them, as a criminally oriented organization, thanks to its oaths of silence and specific requirements for inclusion.

More than 4 million miles of public roads across the U.S. provide vital links for commerce, services, and travel, but they're treacherous barriers for wildlife seeking food, water, and mates. Exposed and unsure about the noisy, unfamiliar terrain presented by an open road, an animal that hesitates or misjudges the speed of an approaching vehicle risks fatal consequences. Unfortunately, those encounters are all too common on busy roadways. According to the Federal Highway Administration, there are more than 1 million wildlife-vehicle collisions (WVCs) every year in the U.S. In addition to the hundreds of thousands of animals killed and maimed, WVCs also result in hundreds of human fatalities and tens of thousands of injuries. Collisions are expensive, too, costing more than \$8 billion annually in vehicle repairs, medical costs, and carcass removal.

Roads can also disrupt migratory routes, divide up ecosystems, and inhibit intermingling, confining entire species to ever-shrinking habitats. A report by the U.S. Department of Transportation found that these crashes are among the biggest threats to the survival of 21 threatened or endangered animal species, from reptiles like the desert tortoise to mammals like the San Joaquin kit fox. It's not just a direct killing that is a threat to the persistence of these species. It's also habitat fragmentation and having smaller and isolated populations that may ultimately go extinct.

The word roadkill has been in the American vocabulary since the late 1940s, but it's only been in the last several decades that studies have emerged examining the effect of roads on animals and the environment. One solution that's gaining traction is the wildlife crossing. Built over or under roadways, crossing structures allow animals to use custom-designed bridges and tunnels to get to the other side safely.

This results in inefficiencies and missed opportunities for innovation that could arise from more integrated collaboration across these educational divides. Over time, the Craftsmen, feeling marginalized, have increasingly organized into unions and guilds to protect their interests and promote the importance of practical skills. They advocate for educational reforms that recognize and elevate vocational training and seek greater influence in policymaking to ensure a balanced development that respects and integrates all forms of knowledge.
