#### Passage-I

The last thing that a rape and murder need are platitudes, and a predictably tiresome one is being peddled after the brutal killing of a woman doctor on duty at Kolkata's R.G. Kar Hospital on August 9. One of the guidelines issued by the West Bengal government calls for minimising night duty for women. How will this dictum — "wherever possible, night duty may be avoided for women to the extent possible" secure safety at the workplace? This regressive move will end up only removing women from the workforce, instead of ensuring a stop to violence. With the labour force participation rate for urban women in India, ages 15 and above, pegged at an abysmal 25.2% in April-June 2024, according to the Periodic Labour Force Survey's quarterly bulletin, the governments at the Centre and States must ensure that women, employed as health-care professionals, gig and factory workers, call centre staff, auto drivers, hotel duties and journalists, are able to work safely, anywhere, and at anytime. Reducing their time at work will only lead to women losing jobs and their financial independence. The other guidelines, as part of the programme called 'Rattirer Shaathi (helpers of the night)', include the call for separate rest rooms and toilets for women, creating safe zones with CCTVs, and a special mobile phone app — measures which should have been already in place.

#### PASSAGE - II

I was always obsessed with music. I would play, badly, in bands, go to all the gigs and festivals I could, and lie about my age as a teenager so I could DJ in clubs. I would have loved to have worked in music, but I left school at 14 and set up a building and decorating business. By my early 20s, my partner and I had bought a house and we had two young children, but I still wanted to be involved in music in some way.

In 2001, I went to the festival All Tomorrow's Parties, where the lineup was curated by bands and artists. I was jealous. I thought I should either work at being in a band big enough to be invited to create our own lineup, or somehow try to create a festival myself. The latter seemed more doable. I came to that realisation after we had been watching the American indie rock band Yo La Tengo. I stood at the bar with my friend Jason, working out on the back of a cigarette packet how much it would cost. We thought it would be about £120,000. I looked around, and there were 1,500 or 2,000 people at the festival, so it seemed within my grasp. Before then, I'd been going to big festivals and I wouldn't have had a clue how to put on something of that size.

Back at home in East Sussex, it felt like a drunken idea but I couldn't shake it. For the next couple of years, every time I went to a smaller festival, I thought: "I could do this." Eventually, after visiting another one in 2004, I went home and spent two weeks doing research, calling security firms and portable toilet companies. It felt like it could become a reality. 'It was stressful and at one point I was drinking every evening'

The stately homes and wedding venues I contacted all said they wouldn't let us hold a festival. I Googled "festival site to rent", and the only place that came up was Larmer Tree on the border of Wiltshire and Dorset. They said they'd be up for letting us do it if we could get the licence approval, so we had to get councillors on side. The social network Myspace had launched the previous year and I used it to contact bands. It was exciting to get responses – I heard from Stuart Murdoch from Belle and Sebastian and singer-songwriter Devendra Banhart. They didn't seem as untouchable as I'd thought, and they were interested, which felt motivating. The record shop Rough Trade, where I was a regular customer, helped out with contacts.

....I worried about the weather and about making sure we had enough people for an atmosphere. We had sold 1,300 tickets, when we'd budgeted for 4,000, and we ended up giving away another 1,200 just to have enough people there. I knew we would be losing a lot of money – it ended up being about £350,000. I was 25, and if I had been older, I'd have been more cautious. I still had my decorating business, and if I worked really hard for five or six years, I should be able to pay everyone back, I thought.

It was stressful and at one point I was drinking every evening. Just over a week until the festival, I was on the site, driving across a field in the dark. I crashed into a fence, the car flipped over and was a write off. It was a wake-up call that I had to get it together.





On the day we opened, the first band played and I just burst into tears from the emotion and relief. It was finally happening. I remember being very tired and living off caffeine, but there was a buzz and a feeling of satisfaction at the same time that I'd created this thing. I could see in people's faces that it was giving them a moment of escape.

Lots of people said I should pull out, or take a year off to reset, but I felt that if we didn't keep momentum, we'd never go back. The second year, we lost £50,000. By the fourth year, the festival had just about become profitable and I started to pay the debts back. All the stress and anxiety was worth it – I had created the festival I dreamed of. As with all good art, it nourished my soul – everything materialistic didn't matter to me any more. I still get very excited when I discover a new band and for the last 20 years I've been lucky to follow my passion.

Two years into a seven-year degree, I walked away. Now I no longer feel the need to deny my working-class background or change my accent to fit in.

Factual Situation: Vijendra Industries, a large chemical manufacturing company in Gujarat, has been disposing of its waste into a river in the vicinity, a common practice done in the industrial area. This disposal has led to significant pollution affecting the water quality and adversely impacting the livelihoods of local fishermen, who rely on the river for their daily catch. Varun, a leader of the fishermen's association, has gathered evidence of increased pollutants directly linked to the waste from Vijendra Industries and averred this is in violation of environmental protection guidelines and initiated a lawsuit against Vijendra industries seeking remediation and compensation. Decide on Vijendra Industries's liablity-

- (a) Vijendra Industries along with other industries of that area, is liable for all environmental damage and must compensate the local community for livelihood losses and fund the river's remediation.
- (b) Vijendra Industries is not liable because the chemical waste disposal was in line with disposal practices done by other industries.
- (c) Vijendra Industries is liable for the environmental damage and must compensate the local community for livelihood losses and fund the river's remediation.
- (d) Vijendra Industries is not liable as the local government did not enforce environmental regulations actively, absolving the company of direct responsibility.
- **136.** Legal Principle I: The right to privacy is a fundamental right under the Constitution of India. It protects individuals from unauthorized or excessive surveillance by the state or its instrumentality. However the right is not absolute, it can be restricted if infringement of privacy is legally justified, necessary for a legitimate aim, and proportionate to the need that justifies the intrusion.

**Legal Principle II:** If the entire or majority share capital of the corporation is held by the government, it would go a long way towards indicating that the corporation is an instrumentality or agency of the State.

**Factual Situation:** Vasudha Public Telecom ltd., a major telecom operator in New Delhi, implemented an advanced surveillance system to monitor the communications of its users, allegedly to identify and prevent fraudulent activities. This system not only tracks call details but also analyzes and records the content of the communications





without explicit consent from the users for quality, training and selling purposes. Vijay, a journalist known for his investigative reporting on government policies, finds that his communications were specifically targeted, leading to a breach of confidential information. He files a lawsuit against Vasudha Public Telecom ltd., claiming an unreasonable invasion of his privacy rights. Decide.

- (a) Vasudha Public Telecom ltd. is not liable as the surveillance was aimed at preventing fraud, serving a legitimate public interest.
- (b) Vasudha Public Telecom ltd. is only liable for the tracking of call details, not for monitoring the content of the communications.
- (c) Vasudha Public Telecom ltd. is liable because the surveillance was excessive and not proportionate to the intended purpose of preventing fraud.
- (d) Vasudha Public Telecom ltd. is not liable because the journalist does not have a higher expectation of privacy than any other citizen under the law.
- **137.** Legal Principle: I. Nuisance means any action by a person that unreasonably or unlawfully interferes with the use or enjoyment of any other person's property by that other person. Public nuisance is an act which causes any common injury, danger or annoyance to the people in general who dwell or occupy the property in the vicinity. Public nuisance is a crime whereas private nuisance is a civil wrong.
- **II.** In certain cases, when any person suffers some special or particular damage, different from what is inflicted upon public as whole due to public nuisance, right to compensation is available to the person.

**Factual Situation:** Vinod owns a large plot of land in the outskirts of Hyderabad, which he uses for hosting large commercial events. His neighbor, Vishal, operates a small poultry farm that directly borders Vinod's property. Recently, Vinod organized a large music festival, which included heavy lighting and loud music throughout the night. The noise and light significantly disrupted the natural cycles of Vishal's livestock, leading to a decrease in farm productivity. Additionally, the local residents complained about the noise disturbing their peace during the event. Vishal has filed a lawsuit claiming that Vinod's activities constitute a public nuisance and seeks compensation for personal damage. Decide.

- (a) Vinod is liable for private nuisance because his actions unreasonably interfered with the neighboring properties' use and enjoyment.
- (b) Vinod is liable for public nuisance and to compensate to Vishal for poor farm productivity.
- (c) Vinod is not only liable for damages to Vishal's farm productivity but also to local residents for the disturbance caused.
- (d) Vinod is not liable for public nuisance because the music festival was a temporary event and such events do not constitute a penal offence.





- **138.** Legal Principle I: Medical practitioners must exercise a standard of care that is reasonable, competent, and in accordance with the current medical practices recognized by law. Failure to meet this standard, which leads to patient harm, can be grounds for negligence.
- **II**. In cases of medical negligence the principle of *Res Ipso loquitur* is applied. It is an evidential principle and it is intended to assist the claimant, who for no fault of his own is unable to adduce evidence as to how the accident occurred. The principle means the thing speaks for itself.

**Factual Situation:** Dr. Varun, a senior cardiologist at a leading hospital in Pune, prescribed a new medication to his patient, Vidya, who has a history of severe cardiac conditions. The medication, though effective for many, is known for potential severe side effects in patients with Vidya's specific condition—something Dr. Varun overlooked. On the first day, she at her own took double dose but continued with the prescribed dose for two weeks. After two weeks she suffered a significant health setback attributed directly to the medication's adverse effects. It was later revealed that Dr. Varun had failed to review Vidya's full medical history due to time constraints and the hospital's high patient volume. Vidya and her family decide to sue for medical negligence.

- (a) Dr. Varun is not liable as the hospital environment and high patient volume contributed to the oversight.
- (b) Dr. Varun is only liable for the lack of follow-up but not for the initial prescription of the medication.
- (c) Dr. Varun is not liable as Vidya herself took the double dose of the medication which worsened her situation.
- (d) Dr. Varun is liable for medical negligence because he failed to exercise the standard of care expected in reviewing the patient's medical history.
- **139.** *Legal Principle:* Entities that collect and process personal data must ensure its protection against misuse, unauthorized access, and loss. They must also obtain explicit consent from individuals before collecting or using their data, provide clear information about the purpose of data collection, and allow individuals to access, correct, or request the deletion of their data. Non-compliance with these regulations attracts stringent penalties including fines and directives to cease processing activities.

**Factual Situation:** Vasudha Enterprises, a private health insurance company based in Mumbai, recently launched a health monitoring application that collects data on users' physical activities, dietary habits, and medical histories. This app is marketed primarily to existing policyholders to offer personalized health plans. However, it was found that the data collected was shared with third-party marketers without users consent, and a subsequent data breach exposed sensitive personal health information. Varun, a policyholder, discovers his personal data was misused and sues Vasudha Enterprises for violating data protection regulations.





- (a) Vasudha Enterprises is not liable because users implicitly consented to data sharing by agreeing to the app's terms and conditions.
- (b) Vasudha Enterprises is liable because it failed to explicitly inform and obtain consent from the users about the data sharing with third-party marketers.
- (c) Vasudha Enterprises is only liable for the data breach but not for sharing data with marketers, as the terms included a clause on potential data sharing for marketing.
- (d) Vasudha Enterprises is not liable since the health monitoring app is an optional service and not a mandatory part of the health insurance plan.
- **140.** Consider the following legal principles:
- **I.** Food Safety and Standards Act, 2006: The Act mandates accurate labeling, prohibits misleading practices, and ensures that food products meet set safety standards to protect consumer health.
- **II.** Consumer Protection Act, 2019: Provides for the protection of consumers against unfair trade practices and deceptive advertisements, ensuring that consumers can make informed choices based on truthful information.
- **III.** Drugs and Cosmetics Act, 1940: Regulates the import, manufacturing, distribution, and sale of drugs and cosmetics to ensure that they are safe for human usage, effective, and comply with quality standards.
- Which of the following actions violate the above-mentioned legal principle(s)?
- (a) Vidhi Nutrients, a health supplement company, accurately lists all active and inactive ingredients on its products and markets them with verified claims of curing chronic diseases.

- **141.** Consider the following legal principles:
- **I.** Income Tax Act, 1961: Requires all entities and individuals to accurately report income, expenses, and deductions to ensure fair taxation, and imposes penalties for tax evasion or misrepresentation.
- **II.** Banking Regulation Act, 1949: Ensures that banking institutions maintain transparency with their customers about account terms, fees, and interest rates, and operate with the financial integrity necessary for customer trust and economic stability.





**III.** Foreign Exchange Management Act, 1999 (FEMA): Regulates transactions involving foreign exchange and foreign securities, requiring full compliance with all controls and norms to maintain the country's foreign exchange market integrity.

Which of these actions best adheres to the above-mentioned legal principles?

- (a) Avni FinServe, a financial services firm, meticulously reports all client transactions to the appropriate regulatory bodies and maintains detailed records to ensure transparency and compliance with FEMA.

- **II.** Statements made in the absolute privilege means that the person making the statement has the absolute right to make that statement at that time and are not considered defamatory regardless of their content. (e.g., statements made by members of the Parliament during session)
- **III.** A defamatory statement is not actionable if it is expressed as a joke or satire understood as such by a reasonable person.

- **143.** Legal Principles on Trespass under Indian Law:
- *I.* Trespass to land: Trespass to land means interference with the possession of land without consent of the person having the possession of the land. Act of trespass by a person makes him liable.
- **II.** Consent given by the possessor of land negates the act of trespass, provided the consent covers the scope of activities carried out by the entrant.
- **III.** Exceptions: Entry onto land for the purpose of averting an immediate danger to life or property is often considered a lawful excuse for trespass.
- Which of the following acts violates the above mentioned legal principles to attract the liability for trespass?
- (a) Varsha living on rent in Vijay's house, drives nails into the wall of the house, adhering to the rental agreement.

- **Legal Principle I:** An act causing damage, if done under necessity to prevent a greater and imminent evil is not actionable even though harm was caused intentionally or infliction of harm was on an innocent person.
- **Legal Principle II:** In private defence, harm is caused to a person who himself is a wrong doer. The harm is done to prevent the danger. It starts when the person is under a fear of harm by other person. It should not exceed the extent which is required to defend. The wrong doer does not have the right of private defence.
- **Legal Principle III:** In necessity the harm is intended to done, whereas in inevitable accident, the harm is caused in spite of the best effort to avoid it.
- Under which of the following cases, the defenses provided in the principles would not protect the accused from liability.
- (a) Rajat, master of the ship disposed the cargo which belonged to Virat and all other passengers, to prevent the ship from sinking as being hit by a rock, water was filling in it. The act was done without communicating with Virat or any of the other passengers.
- (b) Vijay driving under the speed limit on a highway hits a pedestrian, who suddenly tried to cross the road.
- (c) Sumit, trapped in a room with a poisonous snake, breaks the window of someone else's property to escape.

**145**. Consider the following legal principles:

*I*: Negligence is the breach of a duty of care which results in damage unjustly caused to one party by another.

**II**: To establish negligence, the plaintiff must show that the defendant owed a duty of care, the duty was breached, and the breach directly caused the harm.

**III**: There is no negligence if the defendant could not reasonably foresee harming the plaintiff through his actions, or if the harm occurred due to the plaintiff's own actions. Under the principles of negligence in tort law, who is most likely liable for negligence?

- (a) Vinay, a doctor, fails to inform Vandana of the risks involved in a recommended surgical procedure. Vandana suffers complications that are known risks of the surgery.
- (b) Vishal, while driving, checks his phone and accidentally hits Veer's car, which was parked legally on the street.

- **146**. Consider the following legal principles:

**Principle I:** Any citizen of India has the right to request information from a public authority, which is required to reply expeditiously or within thirty days. This right includes access to records, documents, and other information held by or under the control of any public authority.

**Principle II:** The RTI Act exempts certain categories of information from disclosure if such information can harm the sovereignty and integrity of India, the security, strategic, scientific, or economic interests of the State, relation with foreign States, or lead to incitement of an offense.

**Principle III:** Information that involves personal information, the disclosure of which has no relationship to any public activity or interest, or which would cause unwarranted invasion of the privacy of the individual unless the larger public interest justifies the disclosure, shall not be disclosed.

Under the Right to Information Act, which information request should be granted?

- (a) Vikas submits an RTI application asking for the blue print of a recent government infrastructure project, but the information is denied.

This protection extends for the lifetime of the creator plus 60 years after their death, aligning with the Berne Convention for the Protection of Literary and Artistic Works.
- **II:** Fair use doctrine under Indian copyright law allows for the reproduction of copyrighted material without the need for permission under specific circumstances, such as for criticism, review, research, or educational use, provided that such use is justified, does not constitute a significant portion of the work, and does not impact the commercial value of the original work.
- **III**: Copyright infringement occurs when there is unauthorized use of a copyrighted work that falls outside of fair use exceptions. Infringement can result in civil and criminal penalties, including fines and imprisonment, depending on the severity of the breach and the commercial benefit derived from the infringement.
- Which of the following situations is in line with the above mentioned legal principles to not to attract liability?
- (a) Vikram uses a short clip from a copyrighted film in a video essay critiquing the film's cinematography, which he posts on his educational blog.

**Factual Situation:** Vishal, a contractor in Delhi, issued a cheque to Vinod, a supplier, for the purchase of building materials worth Rs. 5 lakh. The cheque was presented for payment within the valid period but was dishonored due to insufficient funds. Vishal claims that the dishonor was due to a temporary mismanagement of his bank account, as he was relying on receiving payments from another delayed project. Vinod, having faced significant financial strain from the delay, has decided to take legal action, alleging that Vishal had no reasonable ground to believe that the funds would be available in his account when the cheque was issued. Decide





- (a) Vishal is liable because issuing a cheque without ensuring sufficient funds constitutes negligence under the Negotiable Instruments Act.
- (b) Vishal is not liable because the dishonor of the cheque was due to a temporary financial mismanagement, not intentional fraud.
- (c) Vishal is only liable for civil damages to Vinod for the financial losses incurred, not criminal liability, as there was no fraudulent intent.
- (d) Vishal is not liable as the payment failure was due to external factors, namely the delayed payments from another project.
- **149.** Legal Principle: I. Easementary right is a right possessed by the owner or occupier of the land on some other land, not his own, the purpose of which is to provide the beneficial enjoyment of the land which he possesses. This right is granted because without the existence of this right an occupier or owner cannot fully enjoy his own property. An easement is a right that benefits one piece of land (dominant estate) and burdens another (servient estate), allowing the holder of the easement the right to use the servient property for a specific purpose.
- **II.** It includes the right to do or continue to do something or to prevent or to continue to prevent something in connection with or in respect of some other land, which is not his own, for the enjoyment of his own land.

**Factual Situation:** Vikram owns a large coffee plantation in Coorg, Karnataka, which is accessible only through a narrow path that crosses Vivek's property. This path has been used by Vikram's family for decades without objection. Recently, Vivek plans to build a small resort on his property and proposes to close the current path, offering Vikram a longer, less convenient alternative route. Vikram refuses, citing the historical usage and necessity of the original path for his coffee transport, especially during the harvest season. Decide.

- (a) Vikram is entitled to continue using the original path based on an established easement by prescription, given the prevailing and unchallenged use of the path.
- (b) Vikram has no right to insist on using the original path as there is an alternative, albeit less convenient, route provided by Vivek.
- (c) Vikram can only claim an easement if he proves that no alternative exists at all, not merely that the alternatives are less convenient.
- (d) Vivek has the right to reroute the path as he sees fit since the land belongs to him, and offering an alternative suffices his legal obligations.



- **150.** Consider the following legal principles:
- **I.** Building and Other Construction Workers (Regulation of Employment and Conditions of Service) Act, 1996: Ensures the welfare and safety of construction workers, regulating employment conditions and providing for health, safety, and welfare measures.
- **II.** Factories Act, 1948: Protects workers in factories, regulating working conditions, hours of work, wages, and the health and safety of workers to ensure humane working conditions.
- **III.** Occupational Safety, Health and Working Conditions Code, 2020: Consolidates and amends the laws regulating the occupational safety, health, and working conditions of persons employed in various sectors, aiming for a safer and more secure working environment.
